## **RAPID RE-HOUSING**

The goal of the HCRP program is to promote housing stability. Every household assisted by the program is provided case management to help them identify needs, establish a safe living situation, and to create a plan that connects them to the resources needed to help them obtain and maintain housing.

#### Each household's case plan may include:

- · Case Management
- · Referrals to housing opportunities.
- · Referrals to community services.
- $\cdot$  Referrals to employment and or educational opportunities
- · Budgeting assistance.



## WHO IS SERVED Individuals and families who have:

 $\cdot$  No other housing options such as family or friends.

 $\cdot$  Lack the financial resources and support networks needed to obtain immediate housing.

- $\cdot$  Head of household who is at least 18 years of age.
- · Must meet literally homeless definition.

#### Literally homeless definition:

• Sleeping in a place not meant for human habitation ( car, tent, outside, etc.)

- · Residing in an emergency shelter
- $\cdot$  Timing out or graduating from transitional housing
- $\cdot$  In hospital or institution for up to 90 days ( but homeless prior to entry)
- · Fleeing Domestic Violence

· Living in a motel/hotel paid by federal, state or local government programs, or paid by charitable organizations.
