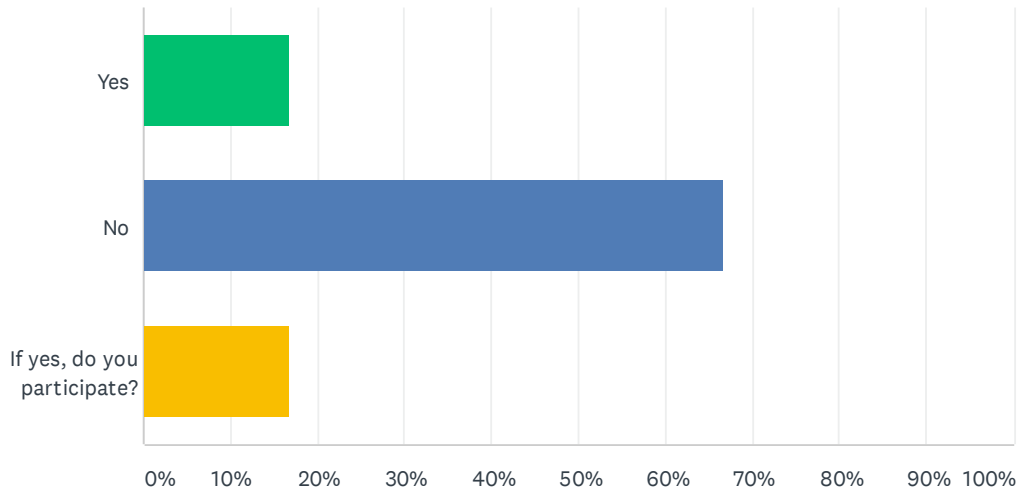


Q1 Are you aware of any available employment tax incentive programs to hire low-income or disabled individuals? If yes, please indicate if you participate in the comment field.

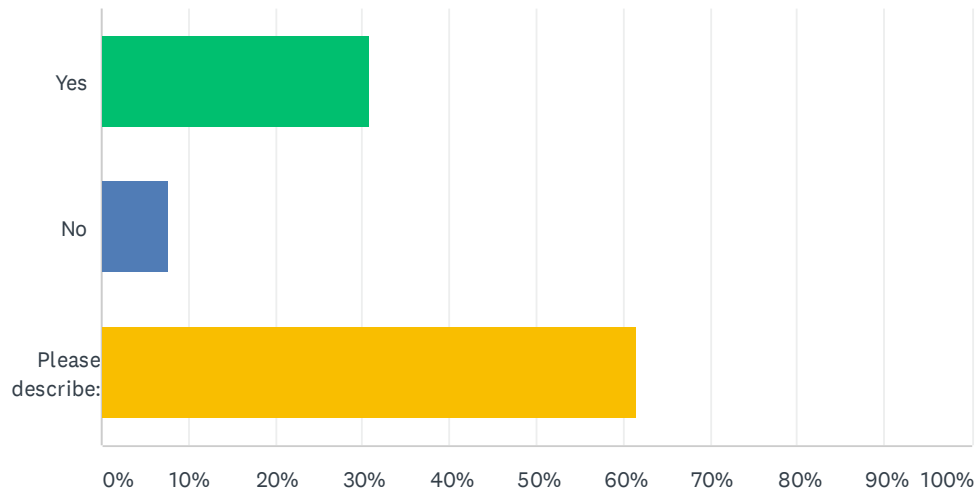

Q3 Do you regularly hire low-income individuals, senior citizens, teenagers? If yes, please describe the population you hire.

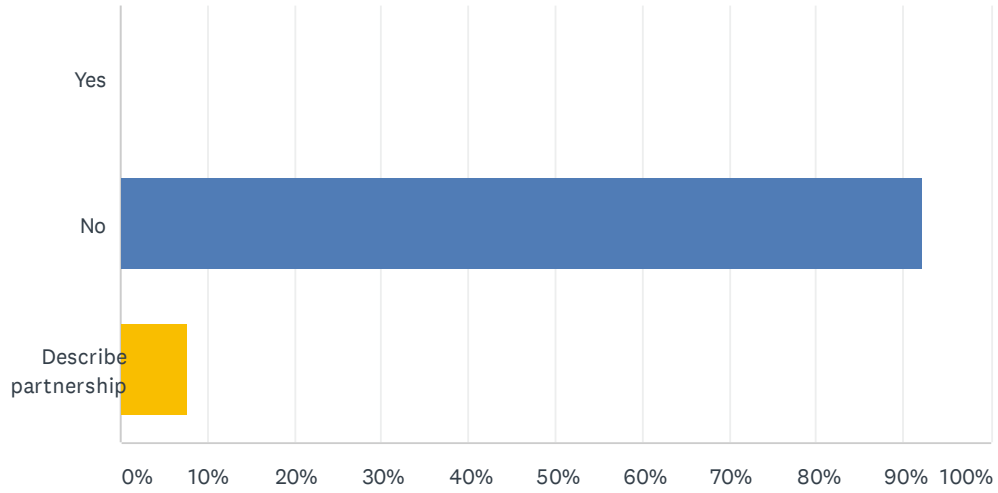

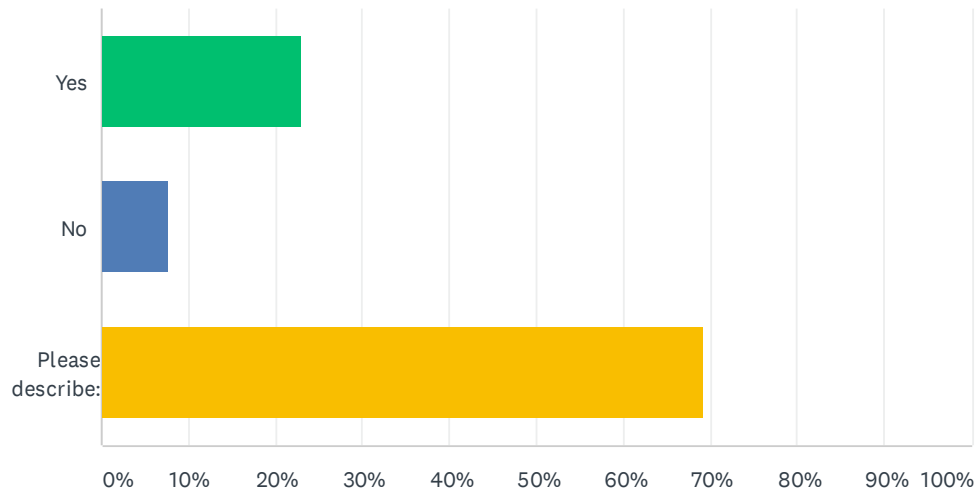

Q5 Is your business interested in partnering with Community Action for any type of workforce development effort? If yes, please describe:

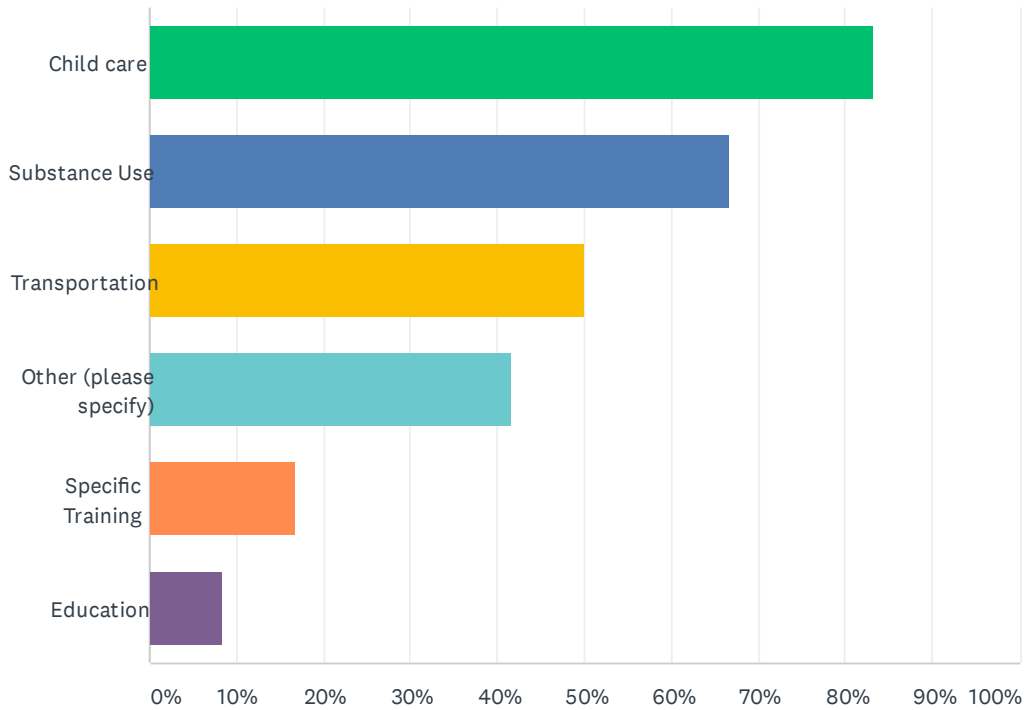

Q6 What do you see as the biggest barriers to employment?

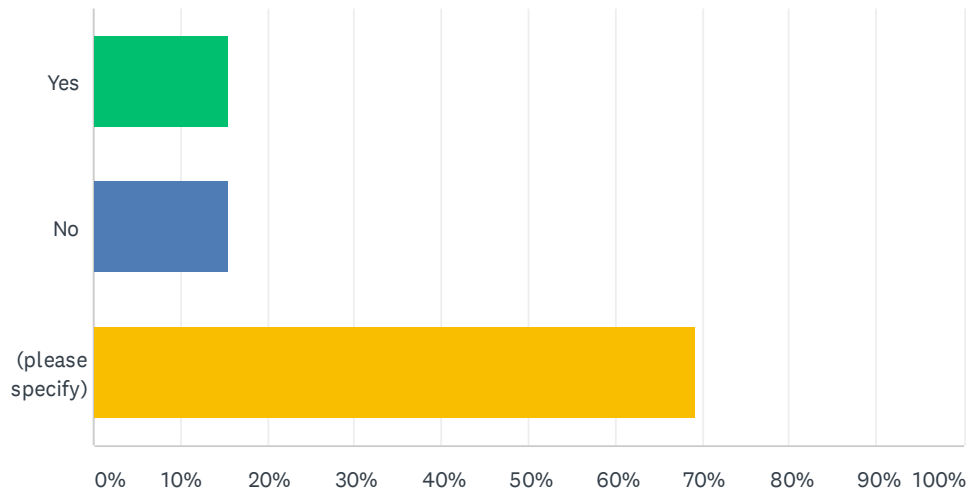

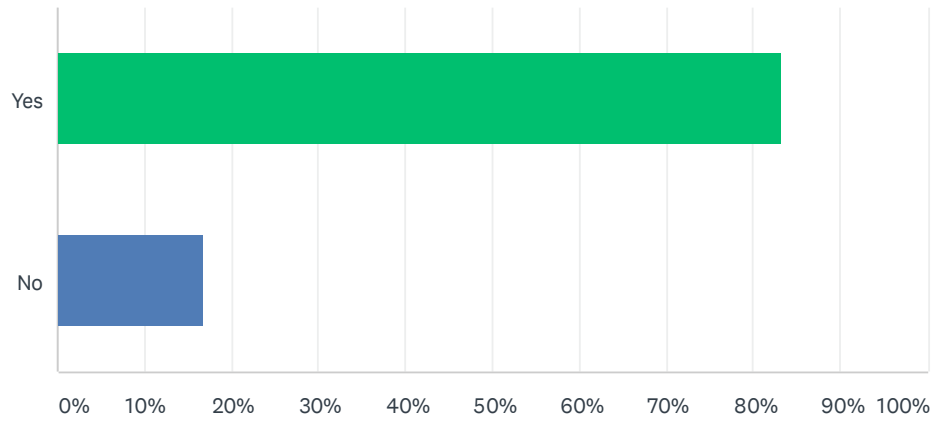
